**What You'll Need:**

1. A computer or smartphone with internet access
2. A valid email address
3. Details about your company's premises and games

1. Create an account on the Jyros website using a valid email address.
2. Log in to your account and navigate to the “Locals” section to enter details about your premises, such as the site name, country, number of employees, and telecommuting policies.
3. Go to the “Games” section and provide information about your games, including the game name, supported platforms, and whether it’s a demo.
4. Use the “Annual Reports” section to generate reports based on the data you’ve entered.
5. Review the reports to understand your environmental impact and identify areas for improvement.
6. Utilize the resources available, such as the user guide and methodological guide, to help you make the most of the tool.
7. Regularly update your information to keep your reports accurate and up-to-date.
8. Participate in training sessions and webinars to learn more about how to effectively use Jyros.
9. Share your findings with your team and stakeholders to promote sustainable practices within your company.
10. Continuously monitor your environmental impact and make necessary adjustments to reduce your footprint.
